Walnut Cove Unrest

The City Fathers in Walnut Cove North Carolina have targeted the Baux Mountain Baptist Church and Pastor Mark Smith. The Church has faithfully presented the Gospel on the street corners of the Town. The intent of the town has been to censor the free speech rights of the church. In their final analysis they now require a permit for the assembling of five or more people within the city limits. Originally they desired to limit the number of permits issued per year and a

thirty dollar fee for each permit. The City Fathers singled out the Baux Mountain Baptist Church in their previous meetings. We have met with Attorney David Gibbs and are in the process of filing a request for injunctive relief and declaratory judgment. This complaint is being filled with the Federal Court since this is a Constitutional issue. We are grateful to Pastor Mark Smith and the Baux Mountain Baptist Church for their courage to take a good firm stand on this important issue.

JUDGE RULES IN FAVOR OF TEN COMMANDMENTS

According to the Courier Journal in Louisville, Kentucky, a Federal Judge has ruled that a Ten Commandments display in the Rowan County Courtroom may remain in the Courtroom. The ACLU had filed a lawsuit asking for their removal. The Ten Commandments were a part of an exhibit which includes eight other documents such as the Magna Carta and Declaration of Independence.

THE "OUT OF SYNC" CALIFORNIA SENATE

A few days ago, the California Senate voted 22-15 to redefine marriage as between any "two persons." They also voted on two companion bills which would force homosexual education and promotion in schools. Another passed bill could ban the use of words like "mom," "dad" "husband" and "wife" and be replaced with "partner 1" and

"partner" 2." These passed bills could also allow male students who "consistently assert" themselves as female access to female restrooms and locker rooms. These bills are now on the desk of the Governor. It is our hope that he will veto these ungodly works of a Legislature out of control. In a previous vote the people of the State of
