The ACLU has placed a law suit against The Forsyth County Commissioners. It is obvious they would like to ban Christianity from the landscape of our Nation. I called my dear friend David Gibbs III who was in South Carolina on another case. He consented to drive to Winston Salem and we met with a partial board of the Commissioners. Dr Gibbs eloquently explained their legal options. A few days later Michael Johnson Attorney with The Alliance Defense Fund met with the full board. On a four to three vote the Commissioners decided to oppose the law suit. The Gibbs Law Firm and The Alliance Defense Fund will be working together to preserve this God given freedom which legally belongs to the American people. This will certainly be a "test case" and may be fought all the way to the Supreme Court. Please pray for these law firms that they will prevail in truth and righteousness!

Abstinence Education

House Bill 879 and Senate Bill 1182 have been introduced in the North Carolina Legislature. These Bills if passed would eliminate the teaching of abstinence before marriage. Beyond that the Bills would require the teaching of comprehensive sex education in our public school system. If passed parents would no longer have control over what is taught in the sex education classes. Many of our leaders in Raleigh are no longer leading. Evidently some of our leadership in Raleigh has never been told that abstinence works 100% of the time. Our school houses must not be turned into animal farms where everyone does what is right in their own eyes. Our Legislators must hear from you! Please call your local Representatives and express your outrage over such foolishness. Our friends at The North Carolina Family Policy are closely monitoring these Bills and will keep us informed.



The purpose of Return America is to build a network of churches and individuals to educate, motivate and mobilize citizens in a united effort in promoting Judeo-Christian values; to educate and influence government in these principles upon which our state and nation were founded.

Hate Crime Legislation

Could you possibly envision your Pastor being arrested for preaching against homosexuality? What about reading passages of Scripture which condemn their lifestyle? If H.R. 1592 passes in Congress sexual behaviors considered sinful and immoral will be elevated to a protected minority class under federal law. Already in Philadelphia eleven Christians were arrested under a Pennsylvania hate crime law for preaching the Word of God at a gay pride rally. They spent the night in jail. Previously protected First Amendment rights will be discarded. Religious teachings and common beliefs will fall under government scrutiny. Other parts of the world including Canada are punishing the clergy for speaking out against what the Bible calls "abomination." You must call your Representatives in Washington and ask them to oppose **H.R. 1592**. (Local Law Enforcement Hate Crimes Prevention Act of 2007) Also mail your opposition to:
